I am one of the co-owners of the DeleteLawz brand, and I vehemently contest Mr. DeCastro's application for the following reasons: Joint Ownership: Mr. DeCastro and I entered into a partnership agreement wherein we agreed to be 50% co-owners of the DeleteLawz brand, including its subsidiary, DeleteLawz Clips. However, Mr. DeCastro violated our agreement by breaching the contract in September of 2023. Independent Operations: Since the dissolution of our partnership, both Mr. DeCastro and I have been operating under the DeleteLawz brand independently, without any involvement from the other party. Harassment and False Claims: Mr. DeCastro has engaged in a campaign of harassment against me, which includes filing false copyright claims, submitting forged documentation to legal entities, and falsely representing himself as the sole owner of the DeleteLawz brand. He has also initiated an online harassment campaign against me, threatening to "ruin" me. Lack of Disclosure: Mr. DeCastro failed to disclose that he is not the sole owner and applicant for the trademark application. His claim to represent a limited liability company (LLC) called Deletelawz is false, as no such organization exists.
